with CCS staff to develop the project list and timeline and reported that the strategic goals were attainable with current staffing profile and spend was included in the drafted FY 21-22 budget.

One potential challenge is the possible addition of Warren-Newport Public Library, but CCS has identified which projects would be prioritized if staff resources were not available.

There was a discussion about the importance of data analysis to help libraries use ILS data effectively for internal decision-making and communication with stakeholders. Malinowski reported that data is a priority and work has already begun to collect data. CCS needs to determine existing skillset and what is the need of the libraries. CCS will gather the data to discuss at Governing Board and will continue to work with individual libraries during this process if they have additional data needs.
