Meeting called to order 9:33.

1. Old Business

- a. Review of the [Bibliographic Input Standards](#) page (Rachel)
 - i. See the [Bibliographic Input Standards](#) document for suggested revisions and comments from the previous meeting's discussion. NOTE: Revisions were saved with tracking changes.
 - ii. Recap on findings about large print edition statement.
 - iii. Discussion on usage of the term foreign language.
 - iv. Options for updating the CCS Core section of the [chart](#) for the future

R. Fischer summarized the suggested revisions that were discussed at the previous meeting. Since the changes are minor, they will wait until more changes have been made to the chart before bringing the document to Governing Board for approval. R. Fischer researched how the large print edition statement would display in the PAC and Vega. She found it is better to leave the statement in the records due to how it displays in the brief view of the PAC. J. King suggested via email that foreign languages be changed to Non-English languages. R. Fischer will make this change. R. Fischer reviewed the two additional columns of Core standards that she added to the chart in the Excel file. One column includes LC-PCC standards from the RDA Toolkit. The other includes the OCLC standards. SCRAP members can begin to research these standards. They will revisit them in the next fiscal year to decide how the chart should be revised for the new RDA Toolkit.

b. National practices review

- i. [Series title vs. main title](#) – Discuss how this page can be clarified.

SCRAP member discussed how this page can be improved by adding additional examples. V. Seward suggested that the page could be less wordy. R. Fischer could not find the minutes from previous meetings on decisions regarding this topic. R. Fischer and V. Seward will discuss how this page can be revised.

2. New business

- a. PS4/PS5 upgrade edition statement (Rachel)

Discussion: Should PS4, PS5 be included in the edition statement? See BIB ID: 2389239.

SCRAP members and attendees compared the difference between the PS4 games that can be upgraded to PS5 to the games that are compatible with XBOX One and XBOX X. In order for the PS4 game to be upgraded to PS5, a separate disc is required. This differs from the Xbox games that are compatible without an extra disc or downloadable file. A 250 with both platforms should be included for the Xbox games, but not the PS4/PS5 games. R. Fischer will revise the statements on the Wiki to clarify this point.

b. Discuss Deschutes Public Library's usage of 9XX field for offensive terms (Tammy)

At the recent LACONI webinar, Emily O'Neil from Deschutes Public Library in Bend, OR, explained how they place the offensive terms (i.e. illegal aliens) in a 9XX field that isn't visible, but searchable in the OPAC. SWAN does a similar thing. SCRAP members are interested in doing more research into the benefits of this. R. Fischer stated that this would require indexing. CCS would not be able to reindex the database until a new member joined. The earliest this may happen is August 2023.

c. Wiki pages that will be deleted due to not being updated (Rachel)

R. Fischer reviewed pages that need to be revised or deleted. The Genre Form heading page has a list of LCGFT that is out of date and hasn't been updated. Notes to updated resources will be added, but the page will be retained. A note explaining exceptions to how the 655 is coded will be added.

d. Plans for the next fiscal year (Rachel)

R. Fischer explained they would continue to have virtual meetings next year. She reviewed the roster to confirm who would be willing to be a member of SCRAP next year.
