## Minutes of CCS Catalog and Metadata Management Technical Group

Zoom meeting Wednesday, February 10, 2021 9:30 A.M.

## Call to order

Chair King called the meeting to order at 9:32 A.M.

## Approval of previous minutes

The minutes of the November 11, 2020 meeting were approved as written.

## Reports of CCS Staff

Rachel reviewed her PowerPoint presentation:

Rachel gave a brief review of cataloging statistics from 2020. COVID-19 had clearly taken its toll on acquisitions and cataloging.

She reported that Database Management discussed forthcoming title records during the November and December meetings and the motion to allow forthcoming title records did not pass. She provided an update from PAS and CIRC/ILL groups on coding serials as monographs. Both PAS and CIRC/ILL Advisory groups wanted to change the catalog as little as possible. There had been no complaints about the serials coded as monographs, and they did not want to change this practice. She also gave an update on the New RDA Toolkit Documentation. The LC-PCC policy statements will not be finalized until 2022. CCS will not require the adoption of the new toolkit until the policy statements are available. She reminded the group that Midwest Tape Binge Box product ID numbers of on order records should be in the 037 and should not be in the 024 field.

SCRAP discussed several cataloging policies at the last meeting and decided to accept them as they were. These included the literary format, not requiring additional tags in vendor cataloged records, not requiring final records to be changed to a full encoding level, continuing to code certain serials as monographs, and how the 240 is used.

ACTION item: Approved recommendation to eliminate local practice of explicitly requiring the 024 field for video game platform numbers.

**Virginia** reported that new subject heading *Nail polish* was added to 8 bibliographic records. RBDigital records were migrated over to the Overdrive platform earlier this month. Overdrive is now loading e-magazines into our system. They will be loading all Zinio titles, so you may get access to more titles than previously. She also loaded over 8400 Kanopy bib. records that we hadn't loaded in over 2 years.
