#### **Old Business**

##### 1. Update on Des Plaines' Local Headings for Manga

Des Plaines Manga Headings	Meaning
Des Plaines (Ill.) -- Josei manga.	Comics for adult women (Proposal submitted to LCGFT)
Des Plaines (Ill.) -- Seinen manga.	Comics for young adult men (NOTE: This is now LCGFT.)
Des Plaines (Ill.) -- Manhwa.	Korean comics (Proposal submitted to LCGFT)
Des Plaines (Ill.) -- Yonkoma.	Four panel gag comics

*Discussion:* R. Fischer briefed the attendees on the state of the LCGFT proposals for the manga genre headings that Des Plaines' uses. SCRAP is interested in allowing the headings that haven't been approved by LC to become local genre headings until they are officially accepted given the decrease in proposals that will be approved before the BIBFRAME transition.

*Motion:* K. Milfajt (MJK) moved and K. Green (PRK) seconded –

Recommend that CAMM allows Josei manga, Manhwa, and Yonkoma as local genre headings in the CCS catalog.

The motion passed unanimously.

2. Feedback from PAS on “Youth literacy materials”

*Discussion:* R. Fischer briefed the attendees on the PAS members’ opinions on allowing “Youth literacy materials” as a local genre heading in the CCS catalog. PAS is supportive of adding the genre heading, but agrees it needs to be tightly scoped in order to be applied effectively. Their suggestion is to apply it to materials intended to teach how to read using phonics/science of reading/teaching concepts as opposed to content or reading-level appropriate materials. This scope differs from the heading for Adult literacy materials which can be applied to reading-level appropriate materials. SCRAP members agreed with PAS’s opinion on it’s usage and scope notes.

3. Potential motion: Recommend to CAMM that CCS allow “Youth literacy materials” as a local genre heading.

*Motion:* N. Mastny (PHK) moved and N. Luque Osuji (WRK) seconded –

Recommend that CAMM allow “Youth literacy materials” as a local genre heading in the catalog with scope notes that it can be used in records for materials intended to teach how to read using phonics/science of reading/teaching concepts as opposed to content or reading-level appropriate materials.

The motion passed unanimously.

*New Business*

4. Should SCRAP consider a local practice regarding the change of the subject headings of “Mexico, Gulf of” to “America, Gulf of” and “Denali, Mount (Alaska)” to “McKinley, Mount (Alaska)”? What makes sense as a best practice to improve access with the consideration that any change may need to be changed back in the future?

*Discussion:* R. Fischer briefed the attendees on the options for adding and replacing headings. This included the differences in the decision-making process and the workflow for bibliographic maintenance. The SCRAP members are in favor of adding the headings “Mexico, Gulf of” and “Denali, Mount (Alaska)” to 691 fields. This can be easily bulk added or removed given the small number of records that the change in the subject heading will affect. They didn’t vote on a motion at the meeting. R. Fischer briefed R. Malinowski after the meeting. She is in favor of having CAMM vote on a motion to add the headings to the 691 field.

#### 5. LDR for serials and the update to serials functions from v. 7.5

*Discussion:* R. Fischer briefed the attendees on the change to holds functionality that improved how holds can be placed on the serials records that aren’t controlled by the serials holdings records. In the past, CAMM decided to catalog certain serials as monographs instead of serials due to how holds functioned. See [Items Cataloged as Serials vs Monographs.docx](#) for the background on this issue. With v. 7.5, the functionality was changed. The holds now function the same regardless of how the LDR is coded. Since the function has been fixed, SCRAP members agreed that the LDR should be changed back to serial. This will allow deduplication to be improved when new libraries add their records. Since this wasn’t a local practice documented in the Wiki, they didn’t feel they needed to vote on a motion. Since CAMM originally made the decision, it will be discussed at the next CAMM meeting.

#### 6. 8XX Fields

- Should volumes go in 8XX even when not in authority records? The national practice is for the 8XX to follow the authority record. The 490 matches how it appears on the item.
- Does a motion need to be passed on this issue or should we wait until a discovery layer is chosen and see if the 490 can be displayed?

*Discussion:* R. Fischer asked SCRAP members for feedback about a potential local practice for adding volume information to the 8XX fields. They do not want to vote on a motion until the new discovery layer is chosen and functionality is known. SCRAP members feel that we shouldn’t vote on a motion to establish a local practice that differs from national practice at this time. Some attendees do not want to make it part of their workflow and others do. SCRAP members felt that catalogers should be allowed to use their judgement to decide if they want to add volumes to the 8XX field when it is not in the authority record. Catalogers should not be required to add the volume, nor should it be considered wrong to add the volume. They did not feel that they needed to vote on a motion for this practice.

#### 7. Modern MARC

- Which fields should be removed or left in records?
  - o URIs in \$0
  - o [758 – Resource identifier](#)
  - o [884 – Description Conversion Information](#)
- LC Plans to eliminate the \$v in favor of using 655s to support URIs

*Discussion:* R. Fischer asked SCRAP members for their opinions on Modern MARC, which is being implemented due to Library of Congress transition to BIBFRAME. SCRAP members felt that URIs and 758s should be left in the records because they could be useful for the future. Since the issue of eliminating the \$v is controversial and a Subject Access Committee working group is forming about it, SCRAP members do not want to vote on a motion until it is considered a national practice. 884 includes unimportant information about converting records between MARC and BIBFRAME and vice versa. SCRAP members feel it can be considered a junk tag.

*Motion:* H. Campbell (LVK) motioned and K. Green seconded –

Tag 884 should be added to the list of system defined tags that can be deleted when records are imported.

The motion passed unanimously.

*Update:* R. Fischer confirmed with R. Malinowski that CAMM and/or DBM do not need to pass a motion to approve adding a junk tag to the list of system defined tags that are deleted since it does not affect the staff workflow. R. Fischer will add it to the list of system defined tags to delete.

## 9. Are there any disability and accessibility headings from the [toolkit](#) that you would be interested in looking into for the future?

*Discussion:* R. Fischer asked if specific headings were of interest. Since there are a lot, the SCRAP members would like to see a report of the number of searches executed using these words. R. Fischer will have it created for the next meeting.

#### 10. Future of SCRAP listserv

*Discussion:* R. Fischer asked how they felt about having SCRAP discussions on the CATS listserv instead of having a dedicated SCRAP listserv since members aren't taken off of the listserv when they are not a member. The SCRAP listserv is used to discuss policies in between meetings. CATS is used to discuss issues with specific records and distribute information. Staff using the CATS listserv may not want to see the discussions. They felt that the question should be asked at the CAMM meeting. Attendees that weren't SCRAP members felt they would like to be added to the SCRAP listserv to see the policy discussion that happens in between meetings. R. Fischer will include it on the CAMM agenda for the next meeting.

#### 11. Preview of Next Year

*Discussion:* R. Fischer encouraged everyone to [nominate](#) themselves for SCRAP and CAMM officer positions. R. Fischer reviewed the list of topics for next year, including reviewing more Wiki pages, discussing updates related to Indigenous people's headings that Backstage could make, discussing local changes for subject headings on topics of disabilities and accessibility, and reviewing a new best practices document from OLAC on media carriers.
