- a. President President Livergood thanked the Governing Board for attending the vendor demonstrations.

- d. Committees and Groups Updates were included in the packet. There were no questions from the Governing Board.
- e. Executive Director Updates were included in the packet. R. Malinowski introduced Molly Sum, Manager of Analytics and Technology.

7. BUSINESS

- a. Vendor Demonstrations R. Malinowski reported that vendor guidelines with board questions were sent to Innovative prior to the demonstration.
 - Vega Discover M. Laude and D. Cooper from Innovative provided a demonstration of the Vega Discover discovery layer and answered questions submitted by directors prior to or at the end of the demonstration.

A question was raised requesting clarification on which products demonstrated are already developed and launched versus ideas or in the works. Innovative reported that Discover, Mobile, Interact, Promote, Web Builder, and Program were all live and launched, and Analyze with Reports is in development.

- R. Malinowski reported that a form will be sent to the Governing Board to complete listing any advantages and disadvantages of Vega Discover and directors can include any outstanding questions for Innovative.
 - b. BiblioCore S. Rhood, M. Tarle, E. Komarnicki, and T. Gordon from BiblioCommons provided a demonstration of the BiblioCore discovery layer and answered questions submitted by directors prior to or at the end of the demonstration. BiblioCommons also provided a brief demonstration of their upcoming AI initiative.

A few questions were raised at the end of the demonstration asking to confirm if BiblioCore would be usable during Polaris downtime, if tariffs might impact the vendor's ability to do business, and clarification on the source used for the slide that referenced vendor trust and various organizations, including public libraries. BiblioCommons replied that there would be some functionality during Polaris downtime and that BiblioCommons does not anticipate any impact or challenges due to tariffs as they are part of a larger operating group with a significant U.S. presence. BiblioCommons stated they would follow up to confirm the site that was sourced and would provide that information.

R. Malinowski reported that a form will be sent to the Governing Board to complete listing any advantages and disadvantages of the product and directors can include any outstanding questions for BiblioCommons. Malinowski will also email the URL to libadmin with the BiblioCommons document.
