Hybrid Meeting Guidelines (Molly)

For our meetings to be successful and useful, we will do our best to adhere to the guidelines below:

- In-person participants should sit near the front and middle of the auditorium to the best of their ability.
- Microphones will be provided and passed around. All participants must use the microphone when speaking to ensure virtual participants are able to hear.
- Virtual participants' chat will be monitored throughout the meeting. Virtual participants should use the chat or unmute to speak when needed.

Staff updates

Rachel:

- *BSLW:* The schedule for Backstage Library Works (BSLW) has been set up. We have two services from BSLW. The Quarterly Authority Notification services sends us new, updated, and deleted authority records on a quarterly basis. It uses our basefile that was processed in June to identify the records that it thinks we need. The controlled vocabularies include LCSH, LCGFT, LC Children's headings, OLACVGGT, Homosaurus, QLSP, and EMBNE. We will be receiving the files during the 3rd week of the last month of the quarter. So, the next files will arrive during the third week of December. The other service is the Periodic Batch Processing of bibliographic records. We have scheduled this to occur every other month. This service provides database maintenance to make corrections to record, such as correcting punctuation and subject headings. They also send back authority records with this process. Since December coincides with the Quarterly Notification Service, we will send our next file for batch processing on December 22nd at 5 PM. This batch will have a first available date of October 16, 2025 – December 21, 2025. It will be processed by noon on December 23rd. The restricted cataloging

procedures will need to be followed from December 22nd at 5 PM until all bibliographic records have been loaded. Thank you again for your patience as we process and import the bibliographic records.

- *Deduplication*: I'd like to thank all of the volunteers that have helped to deduplicate Vernon's records. We are already more than halfway done! Together we have deduplicated more than 8000 records!
- *Polaris upgrade update*: Polaris version 8.0 will be available before the end of the calendar year. CCS anticipates upgrading the training database to 8.0 shortly after the new year. Watch CCS News for updates. Learn more about the new functionality at: [Innovative Product Status Board](#).
- *Images for items with EANs*: Innovative has fixed the problem that prevented the images of products with EANs instead of UPCs from displaying in the PAC. - *Motion passed at the Acquisitions Technical Group* - The Cataloger's Wiki page on [multivolume call numbers](#) has a new section called Volumes in "On Order Item Records" that provides guidelines to comply with a new local practice that the Acquisitions Technical Group passed at the September 17th meeting. See the [draft of the minutes](#) for more information. The section was reviewed by SCRAP at the October 22nd meeting. Please let me know if you have any questions.

Molly M.:

- Bibliocore:
 - CCS has begun the process of implementing Bibliocore as the new OPAC. The Bibliocommons recommended project schedule will be updated to extend the initial library preparation stage, where configuration decisions are submitted to BiblioCommons. This adjustment will provide additional time for CCS to research best practices and incorporate feedback and recommendations from the Database Management Committee.
 - M. Landers presented two options for implementation timeline to Governing Board and has asked for feedback on which timeline works best (Timeline A has the Full Public Launch scheduled in mid-May of 2026; Timeline B has the Full Public Launch scheduled for Fall 2026).
 - This project is on track. Bibliocommons and CCS to review configuration and discuss site scoping. CCS is reviewing the configuration to make standardization recommendations to take to Database Management and develop library configuration surveys. CCS is evaluating updated project plan timelines.
- OrangeBoy:
 - CCS has begun the process of implementing OrangeBoy, a cloudbased tool that consolidates data source information (Polaris, eContent, gate counts, etc) into one platform in order to provide data analysis support for making actionable insights.
 - This project is on track. Polaris data is automated and synching. Standard Reports are enabled. CCS reached out to all member libraries to collect information about each library's potential sources of data and the tools that are used to collect this data. CCS provided Bibliocore with test credentials for eContent accounts and testing is going well. CCS will be collecting eContent credentials from all CCS libraries in the near future.

- Project timeline: CCS staff will begin scheduling training sessions for CCS member libraries in January of 2026 with the anticipated training taking place in February.

SCRAP Report (Rachel)

- *Meeting Summary:* The CCS SCRAP Advisory Group held a virtual meeting on October 22, 2025 at 1:00 PM.
 - The members discussed the creation of Cataloger's Wiki pages for Yotos, Tonie Boxes, and Story Dream Machines. R. Fischer will use the feedback to create drafts of pages.
 - The members discussed the usage of the 099 tag for a videogame platform in final records.
 - K. Milfajt (MJK) motioned and A. Galindo (PAK) seconded: Recommend to CAMM to allow the option to add the video game format, as it appears in the 753 tag, to be included in the 099 tag. This will not be required. The motion passed unanimously.
 - The members discussed changing the requirement for the duration in the 300 field. SCRAP decided it didn't need to change since the language does not require adding the data if it isn't present on the item. This is clear on the bibliographic input standards page.
 - Members reviewed the text of the Wiki regarding the motion passed by acquisitions last month on the volumes in on-order item records. They were fine with the text and had no other suggestions.
 - Members reviewed seven Cataloger's wiki pages to provide feedback on updates. The pages are listed in the minutes. R. Fischer made the following updates:
 - GMD – This page was deleted. The information has been added to [Local practices summary](#).
 - Generic records – This page was deleted. Information was added to the [Unique local materials](#) page.
 - [Genre/form headings](#) – The list of lcgft headings has been removed.
 - Glossary – This page was deleted.
 - [Homosaurus Subject Headings](#) – The text was updated with language about BSLW authority control. Text was added to remind catalogers to check for updated LCSH terms. The CCS staff related language was updated. The spreadsheets still need to be updated, but will be done soon.
 - The next meeting is scheduled for January 21, 2026, at 1:00 PM.

Action item: Vote on a recommendation from SCRAP to CAMM (15 min.)

- *Potential motion:* Allow the option to add the video game format, as it appears in the 753 tag, to be included in the 099 tag in final records. This will not be required.
- *Background:* SCRAP members discussed the possibility of using a local call number field for the video game format at the previous two meetings, because it can display in the results of the find tool. If the videogame format appears in the call number column of the find tool, it will be easier to choose the correct record for the format when the format has been removed from the title. The 099 field takes precedence over the other call number fields. However, the videogame format can be found in the 092 tag of OCLC records inconsistently. If text is placed in the 099 field, it will display in the call number column instead of the 092 tag. In order to standardize the

appearance of the 099 field, SCRAP recommends using the text that is already standardized for the 753 tag in the [Cataloger's Wiki page for videogames](#).

- *Suggested text for the Wiki:*

Local call number (099)

In order to make it easier to identify the correct record for a videogame in a specific format, the videogame format can be added to the 099 tag using the same text as it should appear in the 753 tag. See the section on the 753 tag below. This is optional.
